

Privacy Policy

Protecting your private information is our priority. This Statement of Privacy applies to www.dominiquedawesgymnasticsacademy.com, and Dominique Dawes Gymnastics Academy and governs data collection and usage. For the purposes of this Privacy Policy, unless otherwise noted, all references to Dominique Dawes Gymnastics Academy include www.dominiquedawesgymnasticsacademy.com, KQLD LLC and www.dominiquedawesgymnasticsacademy.com. By using the Dominique Dawes Gymnastics Academy website, you consent to the data practices described in this statement.

Collection of your Personal Information

In order to better provide you with products and services offered, Dominique Dawes Gymnastics Academy may collect personally identifiable information, such as your:

- First and Last Name
- Mailing Address
- E-mail Address

We do not collect any personal information about you unless you voluntarily provide it to us.
